

## Foundational Community Supports (FCS)

### Program overview

FCS is currently one of the original 5 initiatives developed under Washington State’s 1115 Medicaid Transformation waiver, or MTP. In 2018, FCS began providing targeted supportive housing (SH) and supported employment (SE) services to Medicaid beneficiaries with behavioral health needs and other risk factors. By focusing on the social determinants of health, the program aims to reduce barriers and promote health equity. These services are designed to strengthen self-sufficiency by helping participants obtain and maintain housing and/or employment.

These Medicaid-reimbursable services do not replace services that are currently available, and they do not pay for room and board or wages.

HCA has contracted with Amerigroup as the third-party administrator (TPA) to authorize enrollments, pay claims, and manage the FCS provider network.

### Supportive housing services

These innovative services are demonstrating the positive health effects that safe and secure housing can provide to people in need. To qualify, individuals must be Medicaid-eligible, complete a needs assessment, and be experiencing one of the following risk factors:

- Chronic homelessness
- Dependence on costly institutional care
- An in-home care recipient with complex needs
- Dependence on restrictive adult residential care/treatment settings
- At high risk for expensive care and negative outcomes

### Supportive employment services

Supported employment services help people who have physical, behavioral, or long-term health needs that make it difficult for them to find and maintain jobs. These ongoing services include individualized job coaching and training, help with employer relations, and assistance with job placement.

To qualify, individuals must be Medicaid-eligible, complete a needs assessment, and be experiencing one of the following risk factors:

- Eligible for the Housing and Essential Needs (HEN) or aged, Blind, Disabled (ABD) program
- Significant mental illness, substance use disorder, or co-occurring conditions
- A long-term care recipient with complex needs
- An in-home care recipient with complex needs or
- Behavioral health challenges related to vulnerable youth and young adults

### Budget

According to the 5187-S.SL 2023-25 biennial budget Section 211 (4) No more than \$41,915,000 of the general fund—federal appropriation and \$20,310,000 of the general fund-local appropriation may be expended for supported housing and employment services described in initiative 3a and 3b of the MTP.

### Program reach and sustainability

#### Who is enrolling?

To date, more than 21,000 individuals have enrolled in FCS since its inception, including Medicaid recipients who are chronically homeless, have complex behavioral health and co-occurring substance use needs, as well as other long-term care needs or disabilities.

### Our provider network

The FCS program provides statewide coverage through a wide range of service providers, including mental health treatment facilities, substance use treatment facilities, housing authorities, and other community-based organizations. Funding is available annually to incentivize providers serving individuals with SUD to expand SH and SE programs.

## Waiver extension and new initiatives

### Waiver renewal – MTP 2.0

In July of 2022, HCA submitted a formal application to CMS for the renewal of MTP. This new 5-year agreement, known as [MTP 2.0](#), includes FCS as an ongoing program. The MTP was renewed on July 1, 2023, for 5 years under [MTP 2.0](#).

## Apple Health and Homes

The 2022 legislative session saw the passing of [ESBH1866](#), known as Apple Health and Homes. This bill aligns funding for rental assistance and capital construction funds with FCS supportive housing services to create new housing options for eligible individuals to address chronic homelessness. This program is a joint effort led by HCA and the Department of Commerce. The two agencies anticipate launching the program in late 2023.
