

# WISe: Families

## Met ei WISe?

WISe ew pekin aninis (mei voluntary), mei nounou ew "team" ika ekkoch chon anisi pwe repwe awora aninis mei murrinno me tufich faniten semirit. Epwe achocho ne awora "mental health services" (anininis tumwunu ekkewe mei ter me osukosuken non mekurer) pwe repwe anisi noumw we ren ekkoch ekiek pwe epwe sinei ifa usun an epwe pwusin fori an kewe kokkot.

## Popunapen an wor WISe pwe epwe:

- Ew pekin aninis mei awora minne mei auchea fan iten ekkewe semirit mei wor ar nipwakingaw are apwangapwangen non mekurer, pwan faniten nou kewe famini, pwe repwe pochokun, tumunoch, me kinamwe, non famini me sop ika winior.
- Fori an emon me emon "individualized care plan" ika kokkoten wiser, anongonong won ukukun ar sinei, pochokun ika apwangapwang, tongeni, ekiek, me nukunuk. En me an noumw we semirit team oupwe angang fengen me aninis fengen pwe oupwe tongeni sinei met sokkun tumwun ika aninis epwe murrinno faniten noumw we. Ekkewe chon team ra tongeni ekkoch me nein aramasom (usun ekkoch chon famini, chiechi, are sounpetak/wanparun) are/ika pwan ekkoch chon angang (usun ekkoch counselor, chon nemenem, sense, social worker, are probation officer).
- Awora aninis epwe fis non fansoun/kunok me neni omw tawe ngeni (pachanong imwomw, eu neni mei public, are pwan fansoun nepwin ika weekend).
- Aiti ngonuk iten ekkewe ekkoch pekin aninis repwe awora aninis ngeni noumw we me pwan ngeni unusen noumw we famini.
- Awora aninis ngonuk non fansoun atapwanapwan. Noumw we semirit a tongeni angei anininis "crisis services" ika atapwanapwan fansoun meinisin, inet chok epwe tufich. Emon me nein omw na team epwe mwutir anisuk. Ika mei wor namotan, epwe pwan pachanong ekkoch mwichen "epeti seni feiengaw" me non imwom, are ika ia ewe osukosuk mei fis me ia.

## Io epwe tongeni nounou WISe?

Semirit me serafo ra tongeni nounou WISe ika pwe iir mei kis seni ier 21 me ika iir ra pwan fich non tettenin "Access to Care Standards" (pwe repwe sinei met sokkun aninis mei öch ngeni emon me emon mei ter).

## Inet epwe each ngeniei ai upwe tungor ren anininis WISe?

En mei tongeni omw kopwe fori omw "referral" ika tungor ren eu "WISe Screen" (ika Nengeni) inet chok ka mochen. Ka tongeni tungor ren ew WISe Screen faniten noumw we:

- Ika pwe noumw we a men nounou anininis "crisis line" ika ewe emergency room fan chommong, anongonong won weiresin an we osukosuken non mekuran are ika an we "mental health".
- Ika pwe noumw we a kan nukumach (usun, ika pwe a men sunó seni imwan fan chomong, ika a katurunong non konopus anongonong won an osukosuken non mekuran) are ika pwan ekkoch sakkun fofor mei ngaw, nge ese wor och aninis mei fokun anisii.
- Ika pwe noumw we a mochen an epwe afeingawa pusin inisin are inisin pwan ekkoch.
- Ika pwe noumw we a men niit an annininis tumwun ika treatment epwe watteno ika anapano.
- Ika pwe noumw we a men niit och akesiwinin ren an pekin aninis.
- Ika pwe noumw we a men nomw fan ekkoch pekin aninis ika prokram (usun child welfare (CPS), "juvenile justice", anininis ekkewe mei nipwakingaw ika "developmental disabilities services", me/ika treatment ren afeiengawan sakaw/drugs) nge ekkewe pekin aninis ika prokram resapw fokun pochokun ne anisi.
- Ika pwe noumw we a nomw non Special Education me/ika mei wor an 504 Plan, nge a fen suspenini seni sukun fan chommong anongonong won an nipwakingaw are/ika osukosuken non mekuran.

## Met epwe tongeni fis?

Iteiten aramas meinisin repwe tongeni fori ew CANS (Child and Adolescent Needs and Strengths) screening ika chekin. Ekkewe chon tungor repwe tongeni fori ar CANS screen non 10 ran seni ewe ran sia men resifini ar kewe "referral" ika tungor. Ikkei met epwe fis me non ekkewe CANS screen:

Poporaus me kapas fengen me ekkewe semirit, me fori ewe CANS screen, mei kawor rue-me-onu (26) kapas eis me non ena tes. Ena screen epwe pwunguweno ika pwe ewe semirit mei kan chok niit

aninisin/tumwunun WISE are ika pwe esapw. Ekkewe ra mochen fori ewe screen ra tongeni kori kich me non fon, ika pwusin fiti ew mwich ika appointment.

Ika ewe screen epwe pwarata pwe noum we a men niit aninisin WISE, iwe repwe ngonuk ew referral ren omw kopwe churi ew WISE agency ren ewe aewin assessment. Nupwen noum we epwe awesi an we aewin tes, iwe ewe WISE agency epwe aiti ngonuk menni team/agency epwe anisi noum we semirit.

Ika ewe screen mei pwarata pwe noum we ese fokun niit aninisin WISE, iwe ekkewe chon nengeni repwe aiti ngonuk iten pwan ekkoch pekin aninisin "mental health services" (ika tumwunun ekkewe mei ter) repwe tufich ngenii, anongonong won ukukun an nipwakingaw.

## Washington's Wraparound with Intensive Services (WISE)

### *Nenengeni sefani ewe T.R. et al. v. Strange and Birch*

*Won November 2009, ewe Medicaid Lawsuit a faenini (me akom ra aita ngeni T.R. v. Dreyfus) ngeni ewe Department of Social me Health Services me pwan ewe Health Care Authority ren ach sipwe afota ach ekiek ngeni ekkewe semirit me serafo ir mei need aninis. Ewe mwokutukut a anongonong on anukun federal EPSDT ("Early and Periodic Screening, Diagnosis and Treatment") mei pachanong state an epwe awora mental health services me treatment ngeni semirit ir mei need aninis, ika mwo ewe aninis ese kawor me noumw. Me murin ekkoch ier ar akkota ti, me ru kinikin ra tipeew on ew akkot an epwe anisir ren ewe annuk, nge wesen auchean, angang ngeni ekkewe serafo me famini non Washington State. Ewe federal court a mwutata ei Settlement Agreement non ewe December 19, 2013. Nge ar mochen ren ewe Settlement Agreement an epwe awora intensive mental health services (aninis ngeni ekkewe mei rukoruk non mokurer) non iimw me mwuun – ren pekin aninisin safei ngeni ekkewe serafo tori ier 21.*
