Current Family Planning Only Programs

▶ Family Planning Only – Pregnancy Related

- ▶ Formerly known as
 - Family Planning Only extension
 - Family Planning Only
- ▶ This program serves
 - recently pregnant clients who lose Apple Health coverage after their 60-day post pregnancy coverage ends.

▶ Family Planning Only

- ▶ Formerly known
 - TAKE CHARGE
- ▶ This program serves
 - uninsured women and men seeking to prevent unintended pregnancy
 - teens and domestic violence victims who need confidential family planning services

Family Planning Only Programs

▶ Eligible Providers

- ▶ As of July 1, 2019 a client can now seek family planning services through any Apple Health provider.

▶ Increased ease of enrollment as of July 1, 2019

▶ **Family Planning Only – Pregnancy Related**

- ▶ Clients who received Apple Health pregnancy medical coverage are automatically enrolled when pregnancy medical coverage ends at 60 days post partum.

▶ **Family Planning Only**

- ▶ Clients are now able to apply in person, by mail, phone, fax, or email.

Benefits offered to Family Planning Only clients

- Comprehensive family planning preventative visit
- Counseling, education, initiation, and management of contraceptive methods
- Cervical cancer screening
- STD and STI testing and treatment
- Prescription and non prescription contraceptives
- Sterilization procedures

Family Planning Only – Expanding January 1, 2020

- ▶ Who: All individuals at or below 260% FPL who are Washington residents
 - ▶ Regardless of legal status
- ▶ When: January 1, 2020
- ▶ How to apply: In person, phone, email, mail, or fax (same as Family Planning Only applicants)
- ▶ What: The benefit service package will be the same as the Family Planning Only program
