			<p>2019 Endeavors embarked on a mission to expand our services to include whole person wellness and implemented programming focused on stress reduction, recovery, post-traumatic growth and resiliency with educational classes and services on financial wellness, self-advocacy skills, physical fitness, mental wellbeing, relationship skills and improvements, parenting support classes and more. Since 2019 we have provided access to these services to over 12,000 Veterans, Military, their families in mental health services and/or being assisted with housing, Mothers who are in recovery and were previously unhoused, Single adults and families who were re-housed during the COVID 19 Pandemic, Young adults who aged out of the foster care system who were unhoused and then rapidly re-housed, those living with serious mental illness and individuals seeking recovery from substance use disorders. Additionally, the Endeavors Wellness Model has been implemented in a program caring for unaccompanied minors where we have provided services to over 30,000 children in two years with compassion, a focus on health and wellness to include opportunities for culture expression through art and music, emotional support with pet therapy and encouragement and empowerment with age appropriate physical activities, stress reduction and relationship skill building. Our clients served overwhelmingly report satisfaction with services, over 80% remain housed and 90% of clients report they would recommend Endeavors to their friends and loved ones.</p>
