**Dunuubiy:** booy qog naag doonguch ni ba qaraay, nga, laan, ea ngeak, etc.

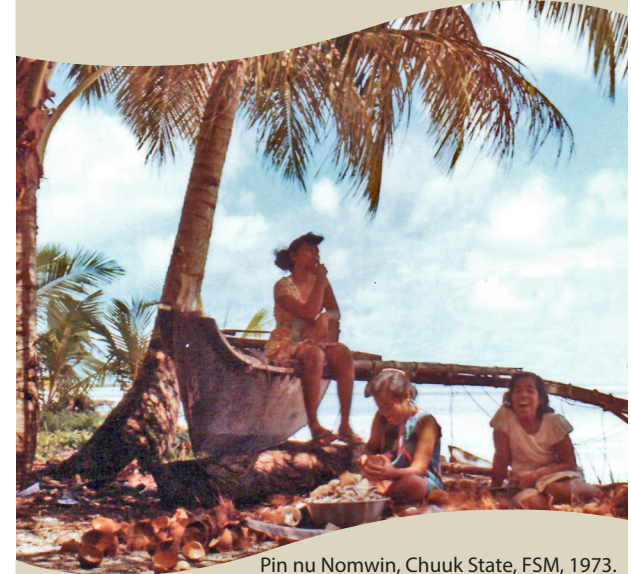
