# Limited enrollment

---

- ▶ Apple Health Expansion's funding was determined by the 2024 legislative session.
- ▶ Due to a limited budget, the Health Care Authority (HCA) needs to manage the number of people who can enroll into the program to ensure clients receive the highest value care possible.
- ▶ HCA plans to enroll up to 13,000 people into Apple Health Expansion. This includes people transitioning from other coverage types\*.
- ▶ This will be managed through a limited enrollment process.

# Who is eligible?

---



- ▶ Jovani is 52
- ▶ He does not have an immigration status
- ▶ He does not qualify for a federally funded Apple Health program or advance premium tax credits (APTC)
- ▶ He makes \$1500 a month
- ▶ He meets eligibility criteria for Apple Health Expansion\*
- ▶ **Next Step:**

# Who is eligible?

---



- ▶ Corina is 35
- ▶ She is lawfully present and has not met the 5-year bar
- ▶ There are 2 people in her household
- ▶ She makes \$2700 a month
- ▶ She may be eligible for may purchase an Immigrant Health Coverage Qualified Health Plan (QHP)
- ▶ **Next Step:**

# Who is eligible?

---



- ▶ Ramon and Jasmine are 26
- ▶ Neither of them have an immigration status
- ▶ There are 4 people in their household
- ▶ They make \$2800 a month
- ▶ They meet eligibility criteria for Apple Health Expansion\*, while children could be eligible for Apple Health for Kids
- ▶ **Next Step:**

---



- ▶ Gloria is 72
- ▶ She does not have an immigration status
- ▶ There are 2 people in her household
- ▶ She makes \$1500 a month
- ▶ She meets eligibility criteria for Apple Health Expansion\*

# Who is eligible?

---



- ▶ Amy is 38
- ▶ She is lawfully present and exempt from the 5-year bar
- ▶ There are 3 people in her household
- ▶ Household income is \$2700 a month
- ▶ She is eligible for Apple Health for Adults
- ▶ **Next Step:**

# Who is eligible?

---



- ▶ Aliyah and Charlotte are 29
- ▶ Aliyah is a citizen and Charlotte does not have an immigration status
- ▶ Their household earns \$2800 a month
- ▶ Aliyah is eligible for Apple Health for Adults and Charlotte meets eligibility criteria for Apple Health Expansion\*

# Who is eligible?

---



- ▶ Jackie is on Apple Health for Kids and turns 19 in June 2024
- ▶ Deferred Action for Childhood Arrivals (DACA) applies to Jackie
- ▶ Jackie's household is 3 and has 0 household income
- ▶ Jackie meets eligibility criteria for Apple Health Expansion\*
- ▶ **Next Step:**

# Who is eligible?

---



- ▶ Glenn is 68 and his wife Olivia is 65
- ▶ Glenn does not have an immigration status and Olivia is a citizen
- ▶ Olivia receives Medicare coverage
- ▶ Their 2-person household monthly income is \$1500
- ▶ Glenn meets eligibility criteria for Apple Health Expansion\*. Olivia may be eligible for the Medicare Savings Program (MSP) or purchase a Qualified Dental Plan (QDP).
- ▶ **Next Step:** Glenn applies for Apple Health Expansion at [washingtonconnection.org](https://www.washingtonconnection.org). Olivia may purchase a QDP at [wahealthplanfinder.org](https://www.wahealthplanfinder.org) or apply for the MSP at [washingtonconnection.org](https://www.washingtonconnection.org)

# Who is eligible?

---



- ▶ Natalia 55 years old
- ▶ Her income is \$2,200 each month
- ▶ She lives in Bellingham
- ▶ She is over income for Apple Health Expansion.
  - ▶ All clients can purchase a Qualified Health Plan
  - ▶ Clients under 250% FPL are eligible for Cascade Care Savings if they enroll in a Cascade Care plan
