

## How long will I have coverage?

Your Family Planning Only coverage is one year from the time you were approved for the program.

## What do I do when my coverage ends?

You can reapply for Family Planning Only coverage after you receive notification by mail that your coverage is ending. If you have had a change in income or household size, you may be eligible for free or low-cost Apple Health coverage.

## Does Apple Health (Medicaid) coverage also include family planning services?

Yes. Apple Health provides full-scope coverage with additional benefits. For more information, visit [hca.wa.gov/apple-health](https://hca.wa.gov/apple-health).

## Can I apply for Apple Health while I have Family Planning Only coverage?

Yes, you can apply for full-scope Apple Health coverage at any time.

## How will I know if I am approved and when my coverage begins?

You will receive an approval or denial letter from the Health Care Authority (HCA) by mail. If you are approved, your coverage begins on the first day of the month you applied.



## Family Planning Only (FPO) coverage

*How to access family planning services.*



## Why should I apply for Family Planning Only (FPO)?

You should apply if:

- You are uninsured and in need of family planning services (contraceptive care/birth control method), **or**
- You are insured and a victim of domestic violence or under 18 and seeking confidential family planning services.

## What services are covered?

- Family planning education and risk reduction counseling
- All FDA approved birth control methods including: pills, patches, rings, shots, IUDs, implants, diaphragms, cervical caps, condoms, and spermicides (foam, cream, and gels), and emergency contraception
- Education and supplies for natural family planning and abstinence
- Permanent birth control methods: tubal ligations (“tubes tied”), sterilization, and vasectomy
- Screening and treatment for sexually transmitted infections (STI)
- Screening for cervical cancer and a well woman physical exam
- Office visits directly related to a family planning problem when medically necessary
- Human papillomavirus (HPV) and Hepatitis B vaccinations.

## Where can I receive services?

You can receive family planning services at any eligible Apple Health provider.

Condoms and spermicides (contraceptive foam, cream, gels) are available at pharmacies without prescription.

Emergency contraception is available at any eligible Apple Health provider or directly from a pharmacist although you may need to have a prescription depending on the medication type.

## Where can I find a provider who offers Family Planning services?

### Am I eligible?

You must meet income limits and be either:

- Uninsured and not eligible for Apple Health (Medicaid) coverage, **or**
- Insured and seeking confidential family planning services.

## How do I apply for coverage?
