

# Washington State Healthy Youth Survey

## Overview

Washington State has been administering the school-based Healthy Youth Survey (HYS) biennially since 1988. The survey measures health behaviors and risk/protective factors that contribute to the health and safety of adolescents in Washington State. Approximately 208,000 students from all 39 counties participated in the 2021 HYS.

Survey data are used to measure progress toward statewide prevention and health promotion initiative goals. Multiple state agencies use survey data for strategic planning and surveillance of youth health risk behaviors and related factors. The survey is also a source of data for multiple Results Washington measures.

HCA's Division of Behavioral Health and Recovery (DBHR) uses the survey data for almost every aspect of the statewide Community Prevention and Wellness Initiative (CPWI), including:

- Risk assessments and rankings to identify the highest risk communities in each county.
- Data for CPWI community-level assessments, planning, and tracking progress on outcomes in their strategic plans.
- Evaluating CPWI's progress in reducing substance use, mental health problems, and the risk factors that predict those problems.

DBHR also uses the survey data for:

- Reporting on Results Washington measures.
- Surveillance of cannabis use among adolescents for reporting related to Initiative 502 (RCW 69.50) which legalized the recreational use of cannabis for adults 21 and older.
- Assessing the co-occurrence of substance use and mental health problems to guide strategic planning.

- Understanding the impacts of health disparities on health behaviors and risk/protective factors.
- Reporting requirements for federally funded prevention-oriented projects.
- Guiding strategic planning of prevention and intervention programs.

# **Eligibility requirements**

The HYS is administered to students in grades 6-12. Prior to 2014, it was administered only in grades 6, 8, 10, and 12. In 2014, eligibility was extended to grades 7, 9, and 11 in small school districts, where the low number of students limits the quality of the data. Tribal schools and online/virtual schools are also eligible to participate, and private schools may participate upon request. Detention facilities are not eligible to participate. The costs to schools are limited to producing information materials for parents and staff time.

# **Authority**

Prior to Initiative 502, the survey was a voluntary collaboration of the agencies listed in the "Partners" section of this fact sheet. However, Initiative 502 (RCW 69.50.550) authorizes the use of cannabis tax revenue to fund the survey and requires HCA to manage the survey.

# Budget

Approximately \$300,000 per SFY from the Dedicated Cannabis Account (DCA).

### **Partners**

Administration of the survey is a collaborative effort among HCA's DBHR, the Department of Health (DOH); the Office of Superintendent of Public Instruction (OSPI); the Liquor and Cannabis Board (LCB); and the current contractor, Looking Glass Analytics, Inc.

Representatives of these organizations serve as members of the Healthy Youth Survey Planning Committee, which guides the survey development and implementation.

### 2023 HYS

The next HYS administration is planned for Fall 2023. This will be the first fully electronic survey administration, with no paper-and-pencil option

available. After a remote survey administration option was approved in 2021 due to the COVID-19 pandemic, the 2023 survey will return to in person; schools that are unable to administer the survey in person (e.g., virtual, online, and other alternative learning experiences) will be allowed to administer the survey remotely. Other changes and updates for 2023 include a simplified survey form and survey question format; display logic and content warnings; additional language options; new questions on topics including bullying, disordered eating, prosocial involvement, screen time, and emerging substances of concern; and updated questions on race/ethnicity, gender identity, and sexual orientation.
