Reasons why rules on this subject may be needed and what they might accomplish: During the 2017 legislative session, the Washington State Legislature passed Engrossed House Bill (EHB) 2242 which created the School Employees' Benefits Board (SEBB) health insurance benefit beginning January 1, 2020. The availability of this benefit, beginning January 1, 2020, means these children no longer meet the definition of targeted low income children under 42 CFR 357.310, and will not be eligible for the Children's Health Insurance Program (CHIP), also known as Washington Apple Health with Premiums Program.
