Title or Subject: Medicaid State Plan Amendment (SPA) 25-0011 Home and Community Based Services (HCBS)- Nursing Facility Methodology and Rate Update

Effective Date: January 1, 2025

Description: The Health Care Authority (HCA) and the Aging and Long-Term Support Administration (ALTSA) of the Department of Social and Health Services (DSHS) intends to submit Medicaid State Plan Amendment (SPA) 25-0011 in order to increase Assisted Living Facility and Private Duty Nursing rates. SPA 25-0011 is expected to:

- Increase the Assisted Living Facility daily rates by a weighted average of \$4.10 to a projected total weighted average of \$150.64, an increase of 3%;
- Increase the Private Duty Nursing daily rate for clients in an Adult Family Home by \$62.72 to \$898.95, an increase of 8%.
