

# Cardiovascular Agents – Sinus Node Inhibitors

### Background:

Sinus node inhibitors reduce heart rate by reducing the frequency of impulses from the sinus node, which is the place in the right atrium of the heart that controls the heart rate. It is a self-administered hyperpolarization-activated cyclic nucleotide-gated channel blocker indicated to reduce the risk of hospitalization for worsening heart failure (HF) in patients with stable, symptomatic HF with reduced ejection fraction (HFrEF).

#### **Medical necessity**

Drug	Medical Necessity
Ivabradine ( <b>CORLANOR</b> ®)	Corlanor may be considered medically necessary when: Used to reduce the risk of hospitalization for worsening heart failure (HF) in patients with stable, symptomatic chronic HF with left ventricular ejection fraction $\leq 35\%$ , who are in sinus rhythm with resting heart rate $\geq 70$ beats per minute and either are on maximally tolerated doses of beta-blockers or have a contraindication to beta-blocker use.

### **Clinical policy:**

Drug	Clinical Criteria (Initial Approval)
Ivabradine (CORLANOR®)	Corlanor may be covered when ALL of the following are met:
	1. ALL of the following:
	a. To prevent worsening heart failure in a diagnosis of stable,
	symptomatic chronic heart failure (New York Heart Association
	(NYHA) class II to IV heart failure)
	<ul> <li>b. Left ventricular ejection fraction less than or equal to (≤) 35%</li> </ul>
	c. Currently in sinus rhythm
	<ul> <li>Resting heart rate greater than or equal to (≥) 70 beats per</li> </ul>
	minute
	2. <b>ONE</b> of the following:
	a. Currently taking maximum tolerated doses of beta blockers
	(e.g. carvedilol, metoprolol succinate, bisoprolol)
	b. Contraindication or intolerance to beta blockers
	3. NONE of the following:
	a. Acute decompensated heart failure
	b. Blood pressure less than 90/50 mmHg
	c. Sick sinus syndrome, sinoatrial block or 3rd degree AV block,
	unless a functioning demand pacemaker is present
