## **Meeting Minutes:**

#### Welcome and Introductions

Welcome by: Aren Sparck, HCA-OTA, Tribal Affairs Administrator & Candice Wilson, DOH, Tribal Policy Director

#### **Opening Statements**

<u>Dr. Umir Shah:</u> Thanked the elected and tribal health leaders for their attendance. Dr Shah welcomed all participants and spoke about the importance of the collaborative work.

<u>Sue Birch:</u> Also thanked Tribal Elected Officials and Tribal Health Leaders for participating in the Consultation and throughout the RT and on the 988 Subcommittee and Tribal Centric BH Advisory Board. Sent appreciation for state agency partners, DOH, HMA and the CRIS Committees for the long-standing work over the past year to update the HB 1477 Crisis Improvement Committee Progress Report.

#### **Purpose of Consultation**

The WA State Legislature passed House Bill 1477 in the 2022 Legislative session, to comply with the national suicide hotline designation act of 2020 and the federal communications commission's rules adopted July 16, 2020, to assure that all Washington residents receive a consistent and effective level of 988 suicide prevention and other behavioral health crisis response and suicide prevention services no matter where they live, work, or travel response improvement plan for the state. This bill required the creation of a Crisis Response Improvement Strategy (CRIS) committee with several partners across the state with several subcommittees, one of which is the CRIS Tribal 988 Subcommittee.

In 2022, the HCA was requested through the Tribal 988 Subcommittee representatives to host Consultation on the CRIS and Technical and Operations Plan in addition to working through the Tribal 988 CRIS subcommittee.

The CRIS committee is not connected to any one agency; therefore, it was determined that HCA and DOH would host the Consultation process in partnership with Health Management Associates, HMA, contractor with the UW Harborview providing coordination of the CRIS.

## Overview of CRIS Work and Overview of the Plan, by Nicola Pinson, HMA

• Nicola reviewed the plan with Tribal Representatives

- <u>Comment Tribe</u>: Emphasis on need for a "payer blind" system that ensures coverage for Tribal members regardless of coverage type. Tribal members covered by Medicaid Fee-for-Service program encounter barriers to care if a provider does not accept Medicaid FFS and the Tribal member is not able to obtain timely approval of coverage through the Medicaid managed care program.
- <u>Response:</u> Thank you for your feedback. Our teams will incorporate your feedback into the CRIS Plan.
