# Legislative Reference

The Health Care Authority (HCA) is submitting this report as required by ESSB 6032, Section 213(5)(oo):

“The criminal justice treatment account—state appropriation is provided solely for treatment and treatment support services for offenders with a substance use disorder pursuant to RCW 71.24.580. The authority must offer counties the option to administer their share of the distributions provided for under RCW 71.24.580 (5) (a). If a county is not interested in administering the funds, the authority shall contract with a behavioral health organization or administrative service organization to administer these funds consistent with the plans approved by the local panels pursuant to RCW 71.24.580 (5) (b). The authority must provide a report to the office of financial management and the appropriate committees of the legislature which identifies the distribution of criminal justice treatment account funds by September 30, 2018.”

## Summary and Background

The Criminal Justice Treatment Account (CJTA) began in 2002 to aid those involved in the criminal justice system gain access to substance use disorder treatment. Specifically, this funding was dedicated to support defendants with a substance use disorder — including those enrolled in a drug court program.

Since the CJTA began, counties oversaw the distribution of these funds. With the integration of behavioral health services in our state in 2016, funding supervision changed to the Behavioral Health Organizations (BHO) or the Administrative Service Organization (ASO), depending on the region and level of managed care integration. Many BHOs and ASOs began to contract with different providers than the counties used when they oversaw the funds. This change, along with administrative barriers, caused difficulties with some regions and providers. For example, some drug court programs could no longer access the funds, which made it challenging to meet their clients’ needs.

The Legislature’s 2018 supplemental operating budget (ESSB 6032) instructed HCA to allow the counties to reinstate their funding oversight. In response, HCA reached out to all county commissioners.

Of the 39 counties:

- 22 reported they would like to leave the funds supervision with the BHO or ASO; and
- 17 — including all of the fully-integrated regions (Chelan, Clark, Douglas, Grant, and Skamania) — would like to reinstate county supervision. HCA is working on contracting updates to make these changes happen.

## County Allotments and Response to CJTA Funds Administration

Table 1 details the breakdown, by county, of allotted CJTA funds for state fiscal year 2019. It also shows each county's response regarding administration of CJTA funds. See the bottom of the table for final totals about who will administer the funds.

Note: The county funding allotment is determined based on a population-based formula used since CJTA began.
