<sup>1</sup> Lower limit date – The lower limit date is 60 days before the current process month. For example: if the current process month is June, 60 days before would be April; therefore, the lower limit date for terminations would be April 30.

<sup>2</sup> Paid – Refers only to the school employee premium share and applicable premium surcharges being received by or withheld from payroll by the school employee’s SEBB Organization.

<sup>3</sup> Current process month – Identifies the specific period of time for which the insurance system is billing a SEBB Organization.

<sup>4</sup> If premiums and applicable premium surcharges remain unpaid for 60 days after the death of the school employee, the deceased school employee’s coverage will be terminated retroactively to the last day of the last month in which the premium or any applicable premium surcharges were paid. The retroactive termination of the deceased school employee’s coverage will impact enrollment eligibility for surviving dependents.

<sup>1</sup> Date of Loss – A dependent's eligibility for enrollment in health plan coverage ends the last day of the month the dependent meets the eligibility criteria as described in WAC 182-31-140.

<sup>2</sup> Lower limit date – The lower limit date is 60 days before the current process month. For example: if the current process month is June, 60 days before would be April; therefore, the lower limit date for terminations would be April 30.

<sup>3</sup> Current process month – Identifies the specific period of time for which the insurance system is billing a SEBB Organization.
