Learning to Bridge

Dr. Pritpal S Tamber is an independent writer, researcher, and consultant. His work examines the realities of bridging the health sector and communities. It is fueled by the insight that health care in high-income countries is increasingly unsustainable because clinical science and practice fail to appreciate how people and communities define their health.

In his keynote, Pritpal will explore some recent examples of work between health care and community based human services, and illustrate the uncertainty that lies under the

headlines. He'll also share insights from some of the projects he's recently seen to illustrate how frontline innovators are making progress, despite the uncertainties. He'll end with 12 practice-based principles that he's surfaced through his research, focusing on four in detail.










MAP OF THE CEDARBROOK LODGE
