What is CRIS

- **2020 Fed 988 bill leads to formation of CRIS**
- **CRIS: Crisis Response Improvement Strategy established 2021 via HB 1477**
- **Focus on 3 pillars as per SAMHSA**
 - *Someone to Call*
 - *Someone to Come*
 - *Safe Place to Be*
- **38 members including 4 representing LE (1 open)**
- **Subcommittees: Multiple including LE. All have people with LE on them.**
- **Work of CRIS sent as a report to legislators and Governor's office end of each year since 2021.**

Overview of HB 1477 Steering Committee, CRIS Committee, and Subcommittees

The Steering Committee – with input from the CRIS and Subcommittees – is charged to deliver to the Governor and Legislature recommendations related to funding and delivery of an integrated behavioral health crisis response and suicide prevention system in Washington.

Steering Committee

Role: Make Recommendations to the Governor and Legislature

CRIS Committee

Role: Advise the Steering Committee as it formulates recommendations

Subcommittees

Role: Provide professional expertise and community perspectives on discrete topics*

LIVED EXPERIENCE (LE) SUBCOMMITTEE

- **Keep community updated on what is going on in the CRIS**
- **Empower people with LE to share their stories to identify system gaps and make suggestions on ways to address them.**
- **Inputs are shared with CRIS**
- **LE directly speak to agencies like DOH, HCA, Legislators when they can come, and other agencies that are executing the build out of the system**
- **Share your stories directly at the CRIS mtgs**

2) Open discussion so we can give your stories our full attention and respect. All stories, comments, and questions not related to agenda topics are welcome during this portion

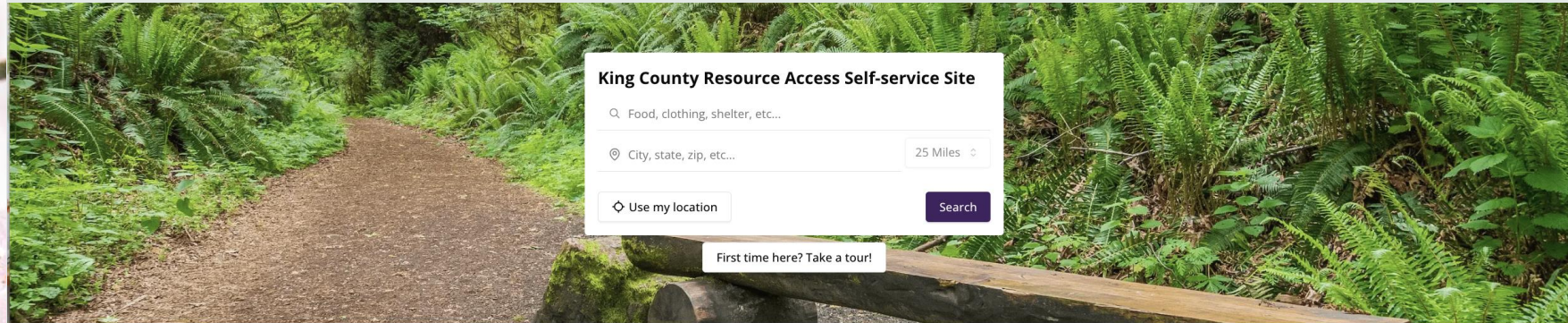

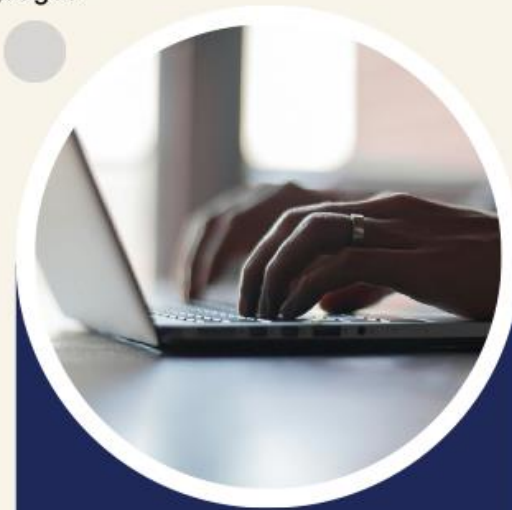

Mental Health Advanced Directive Workgroup

MHAD Workgroup Letter of Interest Announcement

The Washington Health Care Authority (HCA) is establishing and supporting the Mental Health Advance Directive (MHAD) Effective Implementation Workgroup. This Workgroup will be working in 2025 to develop recommendations and training to support creation and utilization of MHADs in Washington. In addition, there will be two Subgroups to inform Workgroup recommendations: the 1) Document Storage Subgroup and 2) Training for Document Creation and Utilization Subgroup. Washington HCA is contracting with Health Management Associates (HMA) to support this work.

The Workgroup and Subgroups are seeking representation from individuals and families from diverse communities who have lived experience of behavioral health crises to be a part of this initiative, including:

- 1) As a member of the MHAD Implementation Workgroup*
- 2) As a member of one of the Subgroups
- 3) Community town halls and listening sessions

**Please note that the Workgroup and Subgroups will have limited seats available, but individuals that are not selected to join the Workgroup or Subgroup will still have the option to participate in additional opportunities (e.g., Town Halls, Focus Groups, Listening Sessions).*

The Workgroup recommendations will be included in a report to the Legislature and Governor due December 1, 2025. The Workgroup will launch early 2025 and meet approximately quarterly throughout the year, with Subgroups meeting monthly. Workgroup and Subgroup members will be requested to participate in meetings and support outreach to their respective communities. Workgroup and Subgroup members who are eligible may receive stipends for participation, in accordance with HCA policy.



National Institute on Drug Abuse (NIDA) Announces People With Lived/Living Experience of Substance Use Workgroup

The National Institute on Drug Abuse (NIDA) recently announced a new working group to the National Advisory Council on Drug Abuse (NACDA) made up of people with lived or living experience (PWLLE) with drug use that will advise on ways to enhance and increase meaningful engagement of PWLLE with drug use in NIDA-funded research.
