## SUBJECT: State Plan Amendment Update to Address Behavioral Health Services CONSULTATION RESCHEDULED

In accordance with section 1902(a)(73)(A) of the Social Security Act regarding the solicitation of advice prior to the submission of any Medicaid State Plan Amendment (SPA) or waiver likely to have a direct effect on Indians, Indian Health Programs, or Urban Indian Organizations, the Health Care Authority (the Agency) hereby seeks your advice on the following matter.

#### **Purpose**

Due to a mishap with not sending a calendar invite for the initial consultation scheduled for March 22, 2023, the Agency decided to reschedule this meeting due to low attendance from tribal leadership. HCA greatly apologizes for this mistake and have rescheduled this consultation to ensure appropriate planning.

HCA intends to submit SPA 23-0010 to update information in the Medicaid State Plan, Attachment 3, Section 13d Rehabilitation Services, as follows:

reformat the section to be more representative of the current behavioral health system (as opposed to the current structure which separates Substance Use Disorder Services and Mental Health Services);

- Reformat the section to be more representative of the current behavioral health system (as opposed to the current structure which separates Substance Use Disorder Services and Mental Health Services);
- Align with new formatting requirements from CMS;
- Expand the provider types who can provide certain services, including being part of a crisis team and providing substance use disorder treatment services;
- Remove outdated mental health peer support language;
- Increase transition of care services available to people with a substance use disorder; and
- If approved by the legislature, allow Medicaid funds to be used on problem gambling treatment services, which are currently paid for with state funds.

This SPA update will create the foundation for future system/service improvements, including removing barriers to deliver more integrated care.
