





An introduction to terms



What does the term "Indian Health Care Provider" (IHCP) mean?

IHCPs are:

- Federally recognized health care systems for American Indians and Alaska Natives.
- Operated by the Indian Health Service (IHS), a tribe or tribal organization, or an Urban Indian Health Program (UIHP).

Note: IHCP is the new term for what was called: Indian Health Service | Tribal 638 | Urban Indian Health Program (I/T/U)


Health care and the trust responsibility

Federal health care for American Indians and Alaska Natives is not part of the nation's social welfare program, nor is it insurance. Rather, it is a program founded upon the federal promise to provide health care services to American Indians and Alaska Natives; a federal promise made in treaties and authorized by the Constitution.



Objectives of health delivery reform: alignment or collision?

Medicaid Transformation objectives

- Integrate physical and behavioral health purchasing and service delivery to better meet whole-person needs
- Convert 90 percent of Medicaid provider payments to reward outcomes instead of volume*
- Support provider capacity to adopt new payment and care models
- Implement population health strategies that improve health equity

*IHCPs are exempt from the statewide strategy on value-based payments
