





# Background

- Currently, HCA cannot pay for health care services when a Medicaid enrollee is incarcerated (except for inpatient hospitalizations)
- Medicaid Transformation Project (MTP) is Washington State's Section 1115 Medicaid demonstration waiver, which is an agreement between HCA and the Centers for Medicare & Medicaid Services (CMS)
- MTP (the waiver) allows our state to implement a reentry program starting in July 2025 - the Reentry Initiative
  - Pays for certain Medicaid services up to 90 days before release
  - Scheduled to operate July 2025–June 2028, and may be renewed for more time
  - MTP funding authorized by Washington State Legislature



# Key terminology for the Reentry Initiative

- Provider enrollment
  - How health care providers register with HCA and become approved to participate in the Medicaid program
- ProviderOne
  - HCA's automated system for paying Medicaid claims (provider bills)
- Facility-based staff
  - Health care staff that are primarily employed by the carceral facility
- Accountable Communities of Health (ACHs)
  - Collaborative networks designed to improve health outcomes in specific geographic areas by addressing the social determinants of health and promoting health equity



# Key terminology (continued)

#### Managed Care Organizations (MCOs)

- The five insurance carriers that manage the delivery of Medicaid services to Apple Health enrollees in Washington State
- MCOs are responsible for maintaining a network of providers to deliver Medicaid services

#### MCO contracting process

- Commonly referred to as MCO contracting
- The process in which an MCO agrees to include a health care organization (e.g., clinic, hospital, or carceral facility) into its provider network
- The process is between a provider/facility and the MCO
- Establishes a contracted relationship that allows a provider/facility to bill an MCO for services provided to an MCO enrollee
- Once a contract is established with an MCO, the provider/facility becomes a network provider for that MCO's enrollees



# Key terminology (continued)

#### MCO provider credentialing process

- Commonly referred to MCO credentialing
- The process MCOs employ to ensure that a provider/facility contracted with their organization possesses current and valid license
  - Certification; permit to practice; evidence of the appropriate education and training as applicable board certification; DEA or CDS certificates

#### Opioid Treatment Program (OTP)

Organizations licensed to provide medication treatment for Opioid Use Disorder (OUD), e.g., methadone, buprenorphine, naltrexone



# What is Apple Health?

- Medicaid: A joint federal and state program that helps cover health care costs for individuals with limited resources
- Apple Health: In Washington State, Medicaid is called Apple Health. Apple Health provides physical and behavioral health services for Washington residents who qualify
- Eligibility: Incarcerated individuals must receive an Apple Health eligibility assessment within 24 hours of intake unless their stay is less than 24 hours
  - January 22 learning series webinar will walk through process to check eligibility



#### What services are covered 90 days prior to release?

#### Mandatory pre-release services

- Targeted case management
- Substance use disorder (SUD) medications:
  - Medications for opioid use disorder (MOUD)
  - Medications for alcohol use disorder (MAUD)
- 30-day supply of all medications at release

#### **Optional pre-release services**

- Labs and radiology
- Services by community health workers with lived experience
- Clinical Assessment and Evaluation
- Prescription medications during the pre-release period
- 30-day supply of durable medical equipment (DME) at release



#### Roles and activities in the Reentry Initiative

- Health Care Authority (HCA)
- Carceral facilities
- Providers
- Managed Care Organizations (MCOs)



#### HCA's role

- State agency responsible for the administration of the Apple Health (Medicaid) program in Washington
- Responsible for state compliance with federal Reentry Initiative requirements
- Facilitates coordination between carceral facilities, MCOs, and other partners



## HCA's activities

- Sets program expectations for carceral facilities
- Provides training and education for carceral facilities
  - Webinar learning series
  - Reentry Initiative Policy and Operations Guide
- Enrolls carceral facilities and providers with the Medicaid program to provide medical services
- Approves facilities to go live (operational readiness review)
- Distributes capacity building funds



#### Facilities' role

- Verifies if members of its population are currently Medicaid eligible and for those who are potentially eligible, but not enrolled, facilitates that process
- Identifies providers of mandatory, and any optional pre-release services including targeted case management, to its Medicaid population
- Invests capacity building funding appropriately
- Further develops relationships with partners: MCOs, ACHs, health care clinics



## **Facilities' activities**

- Learn program requirements
  - Attend learning webinars
  - Review and apply Reentry Initiative Policy and Operations Guide
- Complete milestones to go live
- If strategy for providing reentry services involves facility-based staff:
  - Enroll facility and providers with HCA
  - Contract and be credentialed with MCOs

#### Note:

Identify a team to be responsible for different program requirements





## **Providers' role**

- Provider types:
  - Facility-based providers
  - Community-based providers
- Role:
  - Provide Reentry Initiative pre-release health care services to enrollees experiencing incarceration
  - Understand benefit requirements of the Reentry Initiative



## **Providers' activities**

- Enroll with HCA to become an Apple Health provider and get access to ProviderOne
- Contract and be credentialed with MCOs
- Engage with the carceral facilities to prepare to provide prerelease services



# Managed Care Organozations' role

HCA contracts with the following five MCOs to pay for Apple Health clients' health care



coordinated care.







Pay providers for the provision of reentry health care services
Provide enrollees with continuity of care and case management support

Partner with facilities to support meeting program expectations



## MCOs' activities

Contract with and credential providers, as needed

- Plan at least five months for these activities
- For facility-based providers, HCA is waiving the credentialing requirement for the first year of operation
- Engage with carceral facilities and relevant providers to cover pre-release services
- Engage with ACHs to facilitate successful reentry and continuity of care for enrollees



#### MCO contracting and credentialing steps

#### 1 Provider enrollment

- Ensure facility (if using facility-based staff) AND staff are enrolled with HCA to utilize ProviderOne
  - Process can take approximately 10 months to complete
  - Please attend the January 8 learning series webinar for detailed information

#### 2 MCO contracting

- Facilities and providers establish a contractual relationship with MCOs that allows a provider or facility to bill an MCO for services provided to an enrollee
  - > Please allow at least **2 months** to complete this process

#### **3 MCO credentialing**

- Facilities and providers complete credentialing process with each MCO (note that this is different than DOH process)
  - > HCA has established a 12-month grace period from go live to complete this process
