HOW KNOWLEDGEABLE DO YOU FEEL ABOUT SAFE SUPPLY? WHAT ARE YOUR BIGGEST INFORMATION GAPS?

"With the data [presented], speakers and discussions in this group, very knowledgeable!"

"I feel fairly knowledgeable about Safe Supply. I think that the **biggest information gap is** a discussion around what it would look like to allow for more open, regulated access, that reduces barriers as much as possible. Moving away from a medical model that doesn't promote quality of life by having time restraints, locking people to their clinic neighborhoods, etc, will not work for everyone (especially homeless folks who get swept around by so many systems)."

"I feel reasonably knowledgeable about Safe Supply, but would like to **bolster my familiarity with the evidentiary support** in order to better shape my contributions in this discussion. **Regional or county by county information regarding resources and current overdose rates** would be useful for reference during this discussion as well."

WHAT DO YOU SEE AS THE POTENTIAL VALUE OF SAFE SUPPLY?

"A pathway to save lives and give people access to services who wouldn't seek them."

"Not only would it reduce overdose risk by remaining consistent in potency, with people knowing what they're taking, it could also **help with skin and soft tissue infections** as the supply wouldn't have whatever random contaminants that are used to cut the drugs, it could **reduce neighborhood violence**, **reduce negative police interactions** with neighborhoods that lead to further violence and mistrust, **reduce incarceration rates** and burden on a prison system that fails to provide adequate care, reduce the negative outcomes that result from removing people from their communities and to those who depend on them for support, increase people's capacity to make decisions in their lives and experience pleasure and connection, **reduce stigma**, allow people to hold steady jobs, and the list goes on..."

"The value of safe supply appears to be **quality of life improvements** and **reducing overdose deaths.**"

WHAT CONCERNS DO YOU HAVE ABOUT SAFE SUPPLY?

"Changing the platform to make a true impact and gain main stream approval. We know its the right thing to do but it keeps getting overlooked."

"I have concerns about the **political landscape** primarily at this time." in parallel with "How can this **be pragmatically implemented in the US?**"

"My concern is creating something so narrow that it doesn't help enough people, particularly those who are most marginalized."
